

# ARCHOS: Offer to acquire 100% of the shares of O2I Ingénierie

**Igny, May 27, 2025** - O2i Ingénierie, founded in 1989 and a subsidiary of the Prologue Group, specializes in digital transformation, deployment, and maintenance of information systems, including secure hosting, messaging, backup, and monitoring, for its institutional, key account, and SME clients.

As the first Apple Business Services certified professional integrator and Jamf Gold Partner (Apple fleet management), O2i is also a Microsoft Certified Solution Provider Partner and a cybersecurity solutions integrator with an annual turnover exceeding €11 million. The company is profitable and debt-free.

The convergence of O2i's activities will position the Group as a unique player in digital transformation, able to meet the challenges of its institutional and industrial clients in managing their product fleets and mobile technologies.

This acquisition will enable the ARCHOS Group to strengthen its service activities towards businesses and defense and to aim for hyper growth of around 100% in 2025, representing a consolidated turnover of more than €60 million.

O2i will enable ARCHOS, Logic Instrument, and Elexo to offer digital transformation services to their partners, ministries, integrators, and major European industrial groups.

#### **Operation schedule**

ARCHOS today signed a firm promise to acquire 100% of the shares of O2i Ingénierie. The transaction (€0.3 million) remains subject to consultation with Prologue's employee representative bodies, approval, and the signing of definitive documentation, and is expected to be finalized by July 1, 2025.

## **Outlook**

This new acquisition significantly accelerates the group's transformation.

The professional offering will now combine a comprehensive range of mobile solutions, a team of experts for multi-site implementation, and comprehensive expertise in Apple, Google, and Microsoft systems and cybersecurity. O2i will also add the integration of AI and cybersecurity modules to its offering.

The Group is targeting strong organic growth in 2026 and is not ruling out acquisitions to complement its offering and reach €100 million in 2027.
